**NOW, THEREFORE**, in consideration of the mutual promises and covenants hereinafter set forth, the parties agree as follows:

### **1. OBJECTIVE**

The Times Group aspires to improve the employability of youth from the underprivileged sections of the society by training them on spoken English. This initiative will be implemented by the aforementioned college who will provide classrooms and get learners in the classes. The Times Group will manage and fund the entire initiative, provide course material to the learners and also train the college teaching staff. The Times Group will also select and train volunteers and link them with the college to teach the learners.

This agreement is between the Times Group and the partner college for a 2.5 month period.

### **2. DELIVERABLES**

#### **2.1 Deliverables of NGO:**

The college represents and provide warranties to BCCL that it shall complete and perform the following deliverables for the purposes of this Initiative / Agreement.

#### **2.1. A College - Overall:**

- (i) The college shall provide a room for running the classes and shall adequately maintain all the classroom infrastructure.
- (ii) The college should also take steps to ensure that attrition is kept in check and should involve the Times Group if at any stage they foresee any problem of attendance.
- (iii) The college will be responsible for promoting the spoken English classes amongst the target learners.
- (iv) The college should conduct three to four batches for the course and enroll 25-30 learners in a batch. Depending on the availability and convenience of volunteers and in consultation

with the Times Group the college can schedule the batch timings.

- (v) The college should hold the spoken English classes on six days a week - Monday to Saturday.
- (vi) The college should promote a relationship of trust and mutual understanding with the volunteers and take care of their reasonable needs. If at any stage the college foresees a deterioration in the relationship, the college should immediately make the Times Group representative aware.

#### 2.1. B College - Curriculum development:

- (i) The CSR dept team members will be visiting the college premises to evaluate the classes. The college has to coordinate this and ensure that the team members do not face any inconvenience. The college should also facilitate interactions between the curriculum developers and learners, teachers and volunteers whenever required.
- (ii) The college might be required to conduct small surveys amongst the learners, teachers or volunteers. The college should complete these tasks proficiently and on time.

#### 2.1. C College - Volunteers:

- (i) After the volunteer is assigned with the college, the college shall coordinate daily with the volunteers regarding the classes.
- (ii) The college should make the class ready to receive the volunteer as teacher and provide him/her all necessary support to conduct the class in an effective way
- (iii) The College shall help organize Volunteer and Learner feedback sessions for The Times Group.
- (iv) In case of any issue arising with the volunteer, the college should immediately involve The Times Group team to take care of that.

#### 2.1. D College - Learner:

- (i) College shall enroll learners in batches of 25-30 for the spoken English class and take care of all related formalities with regard to their admission in the class.
- (ii) College shall reach out to the potential learner for the project who would typically fit the description as given below:

- a) Is above 18 years of age
- b) Has a monthly family income of 20-25 thousand
- c) Has had basic introduction to English in school but never used it in daily life
- d) Seeks to improve employability through the course

(iii) College shall:-

- a) assist potential learners in realizing relevance of course
- b) ensure enrollment of 25-30 learners per batch and 3 batches in a day

## 2.2 Deliverables of The Times Group:

### 2.2. A Times Group - Overall:

- (i) The Times Group will be funding some of the project expenses as mentioned in the Project Funding section / Clause 5.
- (ii) The Times Group will also be responsible for the training of the college Teaching staff (as per their availability and our training cycle) and that of the volunteers for the delivery of the spoken English training.
- (iii) The Times Group will be providing the curriculum and all the course material. The curriculum is being developed in collaboration with a reputed spoken English curriculum developer.
- (iv) The Times Group will be selecting and training volunteers to teach spoken English. Every volunteer will take three classes for the same batch in a week and will take these classes on alternate days. Hence two volunteers will together teach one batch. The selected and trained volunteers will then be assigned to the college to teach a certain batch of learners. Or there could be a case wherein one volunteer teaches all 6 days of the batch.

### 2.2. B The Times Group - Volunteers:

- (i) The Times Group has convinced like minded persons of the Society to join the Initiative as volunteers. These volunteers are free individuals having no connection of any kind contractual or otherwise with The Times Group, who of their own free will and without any remuneration / fee / payment of any kind whatsoever have decided to selflessly give their services as teachers to teach English Language to the

underprivileged youth/ learners. The Times Group will develop formal association with volunteers and assign them classes based on their area and times preference. The services of the volunteers for the initiative are planned in a manner that their valuable contribution is utilized to the maximum for the cause.

- (ii) Times Group will provide a set of 2 volunteers to the college for conducting classes of a particular batch on alternative days. Or one volunteer for all 6 days.
- (iii) The number of batches to be delivered by set of volunteers will be decided by Times Group. This also means that Times Group can assign as many number of volunteers to the college as they deem fit, in consultation with the college.
- (iv) Times Group shall assess the conduct, actions or performance of volunteers and work on ways of improving them jointly with the college wherever required
- (v) The volunteers would be trained by Times Group to deliver the curriculum in an efficient manner.
- (vi) Times Group would be handling entire management of volunteers including assigning them to the class, deciding their timing, taking feedback of their teaching abilities etc. and would be taking all decisions regarding them.

### **3. REPRESENTATIONS AND WARRANTIES.**

The college represents and warrants to The Times Group / BCCL as follows:

- (a) That it has been validly formed and duly exists as an educational institute, having its office at Chandrabhan Sharma College Of Arts, Science & Commerce Powai, in India.
- (b) That it has the right and authority to enter into this Agreement and is not prevented from entering into this Agreement by its articles of association, by any statute, regulation or order of any governmental authority, or by any license, debt instrument, mortgage, lease, contract, or other agreement or instrument binding upon it or any of its property;
- (c) That it is duly authorized to enter into this Agreement and has taken all necessary action to obtain such authorization, and that no consent of, or notice to, any other individual, private entity or governmental authority is required in connection with the execution, delivery and performance of this Agreement;

#### **4. INTELLECTUAL PROPERTY RIGHTS**

All Intellectual Property Rights including copyright and trade marks rights in or in relation to the Initiative including content, format, concept and the logo of the Initiative and all or any database/(s) , volunteer details, performance reports or other data or information gathered by the college or any other party during the course of implementation of the Initiative shall exclusively remain with BCCL. The college hereby grants to BCCL a right to use, adapt and copy its logo / name for the purposes promoting and execution of the Initiative.

#### **5. CONSIDERATION**

##### **Project Funding:**

- (i) The college will ensure free of cost the availability of a class room for the spoken English course

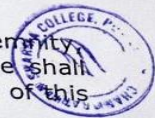
#### **6. TERM**

This Agreement shall be effective/ valid between the Parties from the Effective Date for a six month period. The Agreement may be renewed for a successive period by mutual consent of the Parties on such terms as are agreed upon by the Parties.

#### **7. TERMINATION**

Either Party can exit from / terminate the Agreement without assigning any reason by giving a one month notice in writing. During this one month notice period, the college is expected to deliver all services/ obligations agreed upon by the Parties under the Agreement unless it is decided otherwise. The Times Group may bear liabilities under Clause 5 after termination of the Agreement only in the case where the college is providing services under the notice period.

The representations, warranties of the Parties and the Indemnity, Confidentiality and any unfulfilled obligations by the college shall survive the term and termination or expiry or determination of this Agreement.

The liability if any arising out of actions of volunteers / teaching staff of NGOs shall be solely of the individual only or of the NGO and not The Times Group / BCCL.

#### **10. JURISDICTION**

This Agreement shall be governed by the laws of India and shall be subject to the exclusive jurisdiction of the Courts at Mumbai alone.

#### **11. COMPLIANCE OF LAWS**

The college shall maintain in full force and effect all necessary licenses, permits and other authorizations required by applicable Law to carry out its duties and obligations under this Agreement. college shall comply with all Laws applicable to its activities under this Agreement, including, without limitation, any requirements of declaration, license, insurance, benefits to be given under labour / statutory laws and all applicable State and Central Laws/ rules including on environmental health and safety laws /rules then in effect. The college shall keep all records and reports required to be kept by applicable Laws. The Parties will reasonably cooperate with one another with the goal of ensuring for compliance with Laws. Each Party will cooperate with the other to provide such letters, documentation and other information on a timely basis as the other Party may reasonably required to fulfill its reporting and other obligations under applicable Laws to applicable Governmental Entity/ Authority.

- It is hereby understood and agreed that this Agreement is on a Principal to Principal basis and neither Party shall describe itself as an agent, partner, or representative of the other Party. Any staff including teaching staff deployed by the college for providing training services or any other service shall always be the employees of the college. The Agreement is for a services and first party does not have direct/indirect or any relationship with the employee who has been engaged by the college for providing these services. All persons engaged by the college for providing these services shall be at all times the employees of the college and shall be on it's payroll. The college hereby indemnifies The Times Group / BCCL and shall keep it indemnified free and harmless from claims and demands by such person/persons for any payment and service conditions whatsoever beyond the terms of this contract.
- Both parties undertake to keep confidential and not to disclose any information (written or oral) concerning directly or indirectly the business and affairs of the other, which has been obtained or received during the course of performance of this Agreement.
  - It is expressly agreed that neither party shall be liable for any default, delay or lapse occurring due to reasons of force majeure including war, strike, tempest, terrorist acts, riots, change of law or any act of God. Provided that, in the event the force majeure continues beyond a period of 30 [thirty] days, either Party shall have the right to terminate the Agreement.
- If the disputes and differences cannot be settled amicably within 30 days of the dispute arising then, shall be referred to Arbitration to a Sole Arbitrator to be appointed by BCCL under the provisions of the Arbitration and Conciliation Act 1996 within 30 days. The venue of the Arbitration shall be New Delhi. It shall be governed and construed in accordance with the laws of India.
- All Notices or any other communication to be sent under this Agreement shall be in writing and shall be served by hand-delivery and/or by facsimile or prepaid post and/or courier to the respective addresses of the Parties specified in this Agreement or as may be notified in writing by either Party to the other from time to time.
- The Agreement may be varied only by an agreement document/letter in writing between the parties.

### • 7. Jurisdiction & Arbitration Clause:




