

- Fees:- Strictly as prescribed by the University. Further fees be charged from Reserved Category students as per circular No মিক./মান্দ্রমি(२४)/३६०/२००४ বিনাজ ২৭ এটানেত, ২০০४ and Circular No হি.ক./মান্দ্রমি/ঘর্রে/২/২০१३ বিনাজ ৬ জুন, ২০१३
- No Colleges shall conduct their own CET test for admission for any course of University unless it is an autonomous college.

Further, they are requested to form the Admission Cell/ Committee Comprising of Senior Teaching Staff inclusive of representative of Reserved Category for smooth conduct of the admission process. <u>The vacant seats should be displayed on website</u> and be converted as per the prescribed procedure.

As per the judgment dated 12<sup>th</sup> October, 2017 by the Hon'ble High Court, Bombay, in Writ Petition 1726 / 2001 in the matter of St. Xavier's College and Maharashtra Association of Minority Education Institutions v/s. Mumbai University and State of Maharashtra, in respect of reservation of seats to the backward class candidates shall not apply for Minority Educational Institutions affiliated to the University of Mumbai

Reforms related to student's admission Procedure and terms and conditions to be followed by educational institutions by Religious/Linguistic Minority State of Maharashtra

**Government of Maharashtra Minority Department** Government Circular No: Ashaisam 2012/P.No.21/Work-5 Madam Cama Road, Hutatma Rajguru Chowk Ministry, Mumbai 400 032 Dated: June 18, 2014

Read:- Govt Decision No. Minority Development Department No: Ashaisam-2012/P.No.21/Work-5 Dated 27.05.2013

#### **Preface**:

The procedure, terms and conditions for conferring status as Religious / Linguistic Minority Institutions to educational institutions run by minorities in the state have been prescribed under the relevant Government Decision. Due to the non-availability of students belonging to the relevant religious/linguistic groups provided to the minority educational institutions in the state, the educational institutions running higher, technical or professional courses were frequently asked to revise the procedures, terms and conditions of the government decision. Considering this matter thoroughly, the matter of revising the government decision in the above context was under the consideration of the government.

The above mentioned government decision regarding admission recruitment dated 27.05.2013 vide "A" paragraph no. 105) Amendments are being made to (a), (b) and (c) herein and these amended paragraphs are as follows.

10. (v) - Regarding admission to minorities in higher, technical or professional educational institutions run by minority institutions:- For degree/diploma and further courses, the admission process should be implemented as follows.

AIDED MINORITY EDUCATIONAL INSTITUTIONS: - a) All Minority Educational Institutions should admit through Common Entrance Test or Merit in a transparent manner.

(b) Aided Religious/Linguistic Minority Educational Institutions should give priority in admissions to students belonging to the minority status group in at least 50% of their admission capacity. If the concerned religious/linguistic minority educational institution does not get 50% religious/linguistic students from its minority status group as above, then the following action should be taken.

(i) Aided religious minority institutions:- Aided religious minority institutions should admit students from other religious minority groups as declared by the state government and if students from other religious minority groups are also not available then they should admit students from linguistic minority groups on seats in the minority quota and after that even after making every effort some seats remain vacant. If there are vacancies, non-minority students should be admitted.

(ii) Aided Linguistic Minority Institutions:- Aided linguistic minority institutions should give admission to students belonging to other linguistic minority groups as declared by the state government and if students from other linguistic minority groups are also not available then to admit students from religious minority groups in the remaining vacant minority quota seats and then even after making every effort to fill some vacant seats. If there are vacancies, nonminority students should be admitted.

(iii) Also the remaining 50% of the seats will be filled from the non-minority students of the open category by the concerned educational departments of the state government from the Scheduled Castes, Scheduled Tribes, Nomadic Castes, Exempt Castes Special Backward Classes and Other Backward Classes etc. It is mandatory to give admission as reserved seat for weaker sections.

II Unaided Minority Educational Institutions: - All Unaided Minority Educational Institutions should conduct admission through Common Entrance Test or Merit in a transparent manner.

c) Unaided religious/linguistic minority educational institutions under their admission capacity less than 51% admissions should be given to minority students of the rank group they have obtained.

If the concerned religious/linguistic minority educational institution does not get the above quota of 51% religious/linguistic students belonging to their minority status group, the following action should be taken.

(i) Unaided Religious Minority Institutions:- Unaided religious minority institutions should admit students belonging to religious minority groups declared by the state government and if students from other religious minority groups are also not available then students belonging to linguistic minority groups should be admitted to minority quota seats and after that even if some seats remain vacant even after making every effort. In vacant seats, non-minority students should be admitted.

(ii) Unaided Linguistic Minority Institutions:- Unaided Linguistic Minority Institutions should admit students belonging to other linguistic minority groups as declared by the State Government and if students from other linguistic minority groups are also not available then they should admit students from religious minority groups to the remaining vacant minority quota seats and after that even after making every effort some seats. In case of vacancy, non-minority students should be admitted in the vacant seats.

(iii) Also, the remaining 49% seats should be given to open categories from among the non-minority students in the open category by the respective educational institutions in the open category as well as by their own free will to the Scheduled Castes, Scheduled Tribes, Nomadic Castes, Freed Castes, and Special Categories etc. in order to achieve social justice and balance.

While proceeding as above, the minority educational institutions should publish advertisements in the newspaper as mentioned in paragraph 10(4)

(d) Of Part "A" and in the advertisement the religious/linguistic minority status obtained by the minority educational institution and other religious/linguistic status of the state as declared by the State Government. Applications should be invited from minority and non-minority students, as the case may be. In the above advertisement, it should be mentioned that if only minority status students are not available to the institution, then students belonging to other minority religious/linguistic groups will be given admission on the basis of merit.
